Proof of Qualified Energy Property for Claiming Tax Credits for Residential Heating & Cooling Equipment

The U.S. Internal Revenue Service (IRS) is now providing Consumers with a tax credit on high-efficiency heating and cooling equipment. The Rheem Air Conditioning Division of Rheem Sales Company, Inc. certifies that the following models (if placed in service after Dec. 31, 2005 and before Jan. 1, 2008 in a homeowner's primary residence) meet the criteria of "Qualified Energy Property" as set forth by Section 25C of the Internal Revenue Code:

Qualifying Air Conditioning Systems Tax Credit – not to exceed \$300
